

Wealth Xtra Campaign Terms & Conditions

The offers in the Gibraltar BSN (“GBSN”) Wealth Xtra Campaign (“Campaign”) Terms and Conditions (“T&C”) are effective 1 January 2019. For avoidance of any doubt, Eligible Persons who have applied for Wealth Xtra within 30 days before his/her policy Maturity Date between 1 January 2019 and 15 March 2020 (provided such applications are successfully approved by GBSN before 31 March 2020) will be entitled to a sign up gift (“Gift”) as below:

“Eligible Policy/Policies” shall refer to policy/policies selected by GBSN for this Campaign.

“Eligible Person” shall refer to selected GBSN customers with “Eligible Policy/Policies” maturing from 1 January 2019 to 15 March 2020.

“Successful Applicant” shall refer to the policy owner of Wealth Xtra where the policy has been approved by 31 March 2020.

The following terms and conditions shall apply for Gift:

- a) The Foldable Cabin Luggage (worth approximately to the equivalent retail value of RM150) will be delivered via courier services to the address provided by the Successful Applicant in the Wealth Xtra Proposal Form within ten (10) weeks from the delivery date of the Wealth Xtra policy contract;
- b) The Gift is subject to availability from the supplier. In the event that the supplier is unable to supply the same model of the Gift, GBSN reserves the right, to substitute the Gift with another product of similar retail value;

- e) To the fullest extent permitted by law, GBSN expressly excludes and disclaims any representations, warranties, or endorsements, expressed or implied, written or oral, including but not limited to, any warranty of quality, merchantability or suitability or fitness for a particular purpose in respect of the Gift. All disputes, claims or warranties must be addressed with the supplier or the manufacturer.

GBSN reserves the right at its absolute discretion to approve or reject any application. An Eligible Person who has applied for the Wealth Xtra plan may enquire on the status of his/her application by contacting GBSN Customer Service Careline at 1-300-22-6262.

An Eligible Person may also sign up more than one Wealth Xtra plan where he/she is only entitled to one Gift from the first Wealth Xtra plan approved by GBSN via the channel that the Eligible Person applied from; regardless of the number of successfully approved applications.

The Wealth Xtra policy will commence upon the maturity of the Eligible Policy. No application is accepted after the maturity date of the Eligible Policy.

GBSN's decisions on all matters relating to the Campaign will be final and binding.

GBSN reserves the right to disqualify an Eligible Person/Successful Applicant (as the case may be) from participating in the Campaign and/or from receiving the Gift where the Eligible Person/Successful Applicant has cancelled the application or the application was cancelled by GBSN by any reason whatsoever, either voluntarily or involuntarily.

For the avoidance of doubt, any cancellation, termination or suspension of the Campaign by GBSN (or any individual offer(s) in the Campaign) shall not entitle any Eligible Person or Successful Applicant to any claim or compensation against GBSN for any and all loss or damage suffered or incurred by the Eligible Person, or Successful Applicant whether as a direct or indirect result of

the act of cancellation, termination or suspension of the Campaign or any individual offer(s) in the Campaign.

GBSN reserves the right to vary and/or change any of these terms and conditions with notice. These terms and conditions may be varied or changed by GBSN by way of posting on GBSN Webpage or in any other manner deemed suitable by GBSN.
