

Gibraltar BSN i2u Campaign

Terms and Conditions

1. 'Gibraltar BSN i2u Campaign' ('the Campaign') is organised by Gibraltar BSN Life Berhad ('Gibraltar BSN', 'We', 'Us', 'Our', 'the Organiser'), running from 1 November 2021, 8:30am to 31 December 2021, 11:59pm ('Campaign Period').
2. The Campaign is open to all Gibraltar BSN policyholders for i-Care, i-Med, i-Protect & i-Protect Plus ('i2u Products') who are Malaysians aged 18 and above.
3. Policyholders who purchase any i2u Products online within the Campaign Period with annual payment mode will receive three (3) entries, and monthly payment mode will receive one entry for Campaign Lucky Draw.

Campaign Mechanics
